My Plate will be a hands-on activity that will allow the participant the ability to demonstrate knowledge learned about the plate based on information they received from their book or http://www.choosemyplate.gov/

Practice kits will be available for clubs to check out in June to prepare. In addition members will bring their project book, their portfolio, and menu to judging. Our goal is to better prepare youth who will go on to the state fair.

LIVESTOCK INTERVIEWS

Make sure you should have the newest questions. The new questions will have beginning, intermediate, and advanced all on one paper. Beginners (8-12) have 5 questions, Intermediates (13-15) have 8 questions and Advanced (16-18) have 10 questions. Everyone will have 10 questions total asked of them. Beginners will have 5 general questions about their animal. Intermediate will have two more questions. These could include things like birth date, weight, breed, etc.

We will also have a bonus skillathon station at interviews. This station will be optional for members but 4-H members who do well at this station will be eligible for special recognition. This year, the station will be breeds.

Livestock interviews will be scheduled online. Beginning on August 1 at 10:00 a.m. members can go online and start scheduling their time slots.
